### Scholarship Policy

#### Scholarship Policy

Mansarovar Dental College is run by Sri Sai Gramothan Samiti, Bhopal. To acknowledge such high potential academic achievers, the College offers/assists generous scholarship through society covering part/full academic fee for the entire/part duration of the program. This Policy has been designed to help to effectively administer scholarships, free ships and other financial assistance available at the College.

#### Institutional Scholarship Offered by Sri Sai Gramothan Samiti.

- The fee concession will be restricted to the extent of Tuition Fees, Term
  Fees, Development Fees and Sports Fee only. Any fees that are in the
  nature of re-imbursement to the University/ Education Board/ Insurance
  Premium/ Admission form etc., will not qualify for concession. However,
  society reserves the right to amend the said rule as and when required.
- 2. If the student is availing fee concession facility, then eligibility would be decided on the basis of the performance of the student in the previous/ qualifying examination and the economical condition of the parents. During subsequent years, the fee concession facility would be continued subject to the improvement in academic performance of the student in the class for which fee concession was offered.

3. The quantum of concession in the fees would be based on the annual income of the family from all sources as under; Eligibility for the fee concession will be based on the following income level:

Family Income Level	Concession in %
Rs. 180000 p.a.	100%
Rs. 180000 to Rs. 240000 p.a.	75%
Rs. 240000 to Rs. 300000 p.a.	50%
Rs. 300000 to Rs. 360000 p.a.	25%
Above Rs. 360000 p.a.	Nil

4. The application for fee concession in the prescribed format shall be submitted to administrative office of the college on or before 30th September of every year. Applications received after the said date will not be entertained, under any circumstances. The committee will dispose of the applications reasonably within 30 days from the date of its submission to the office. Those who have been granted concessions shall not be interviewed again and concession would continue until completion of the program in the college subject to conduct & performance of the student. In the event of finding any reasonable evidence that the applicant student family's financial condition is improved, such student shall be called for interview to decide on further continuation of fees concession.

- Application for fee concession should be submitted to Administrative office of the college along with necessary documents.
- The fee concession application shall be recommended by society members or office bearers.
- The Chairman of the society shall have the discretion to sanction fee concession on merit in few deserving cases every year.

#### GUIDELINES FOR SRI SAI GRAMOTHAN SAMITI SCHOLARSHIP

The Scholarships would be conferred upon meritorious and economically weak students. The beneficiaries of the scholarship shall be selected from the applicants, by a Committee comprising of eminent persons. The following criteria shall be used to select the candidates:

- The applicant's Family Gross Income should not exceed ₹ 5,00,000 per annum.
- Application shall be submitted by students seeking the scholarship on the prescribed form. The form requires accurate Academic and Financial Information from the applicant.
- The Awards Committee follows a Graded Score System for evaluating both Overall Academic Performance and Overall Financial Status of the applicant.

Overall Academic Performance is based on average score of all relevant public examinations beginning with class X and ending with the immediately preceding Semester/Final (preferably, public) Examination.

Relevant Examination refers to the examination which has been the basis for promotion or admission to the next class.

Overall Financial Status will be determined taking income from all sources of the applicant's family taking it as a unit.

- The Committee shall identify the student with the highest score for the concerned scholarship.
- The selected candidate shall appear for an interview, if desired, with the Chairman of the Society, at the final stage.

#### Note:

- The Form, duly completed, in all respects has to be submitted in hard copy.
- Scholarship Applications are received Twice a year. The Last Date of Receipt of Applications is 30<sup>th</sup> September and 31<sup>st</sup> March every year.
