महोदय/महोदया,

मुझे यह कहने का निदेश हुआ है कि दंत महाविद्यालयों में रैगिंग के खतरे को रोकने के लिए डीसीआई विनियम, 2009 के अनुसार, यह सुनिश्चित करना सभी संस्थाओं की जिम्मेदारी है कि उनके दंत संस्थान में रैगिंग की कोई घटना न हो और इसे रोकने के लिए किए गए उपायों की समीक्षा की जाए।

2. उक्त विनियम की धारा 11.3 के अनुसार संस्था के अधिकारी/प्रबंधन (ट्रस्ट, सोसायटी आदि), विशेष रूप से संस्था के प्रमुख यह सुनिश्चित करने के लिए जिम्मेदार होंगे कि संस्था में रैगिंग की कोई घटना न हो। यदि रैगिंग की कोई घटना होती है, तो प्रबंधन/प्रमुख उस व्यक्ति (व्यक्तियों) के खिलाफ तुरंत और उचित कार्रवाई करेंगे, जिनके कर्तव्य में लापरवाही से घटना हुई है। ऐसे में संस्था के प्रमुख की नियुक्ति के लिए नामित प्राधिकारी प्रमुख के खिलाफ तुरंत और उचित कार्रवाई करेगा।

3. सभी दंत संस्थानों को शैक्षणिक वर्ष के शुरू होने से पहले और साथ ही सत्र के बीच में साइनबोर्ड, पैम्फलेट आदि के माध्यम से रैगिंग के खिलाफ विज्ञापन जारी करना चाहिए और साथ ही अपने संस्थानों के सभी छात्रों को एक पुस्तिका जारी करें, जिसमें रैगिंग के बारे में विवरण हो, रैगिंग के दंडनीय अपराधों, रैगिंग के लिए दंड एवं सजा, एंटी रैगिंग स्क्वाड, एंटी रैगिंग समिति (एंटी रैगिंग हेल्पलाइन), वार्डन, पुरुष और महिला छात्रावास के उप वार्डन के सदस्यों के नाम और मोबाइल नंबर का विवरण दिया गया हो।

4. सभी दंत संस्थान अपने किसी भी संकाय सदस्य (सदस्यों) को फ्रेशर और वरिष्ठ छात्रों के बीच समन्वय करने के लिए "काउंसलर" के रूप में नामित करेंगे ताकि रैगिंग के खतरे को रोकने के लिए छात्रों (परामर्शदाताओं) के बैचों को दिन-प्रतिदिन की समस्याओं के बारे में नियमित रूप से बताया जा सके या समझाया जा सके और उन्हें रैगिंग के खतरे को रोकने में उनकी भूमिका को संवेदनशील बनाया जा सके।

5. आपसे यह भी अनुरोध है कि बीडीएस/एमडीएस/पीजी डिप्लोमा/पैरा डेंटल कोर्स या डीसीआई द्वारा अनुमोदित/मान्यता प्राप्त किसी अन्य कोर्स में पढ़ने वाले सभी विद्यार्थियों (प्रथम वर्ष से अंतिम वर्ष) और उनके माता-पिता/अभिभावकों से एंटी रैगिंग पर ऑनलाइन www.antiragging.in के माध्यम से वचनपत्र (अंडरटेकिंग) प्राप्त करें और फाइल करें।

6. उपरोक्त के अलावा, यहां यह भी उल्लेख करना उचित है कि संबंधित विनियम की धारा 12.1 के अनुसार, प्रत्येक संस्थान पिछले शैक्षणिक सत्र के संबंध में प्रत्येक वर्ष 31 अक्टूबर तक अपनी एंटी रैगिंग रिपोर्ट डीसीआई मॉड्यूल के एंटी रैगिंग ऑनलाइन पोर्टल पर दर्शाये गये प्रत्येक कॉलम में सामने अपेक्षित जानकारी को अपलोड करेगा, और ऐसा न करने पर, भारतीय दंत परिषद, दंत महाविद्यालयों में रैगिंग के खतरे को रोकने संबंधी विनियम, 2009 की धारा 11.4 के अनुसार, निम्नलिखित में से कोई एक या एक से अधिक संयोजन के साथ दंड लगाएगा :-

7. उपरोक्त के संबंध में, मुझे यह कहने का निर्देश हुआ है कि भारत के माननीय उच्चतम न्यायालय द्वारा नियुक्त निगरानी समिति के अनुरोध और दंत महाविद्यालयों में रैगिंग के खतरे को रोकने के लिए डीसीआई विनियम, 2009 के अनुसार सभी दंत संस्थानों को शैक्षणिक सत्र 2023-2024 के लिए एंटी रैगिंग रिपोर्ट डीसीआई मॉड्यूल के एंटी रैगिंग ऑनलाइन पोर्टल पर निश्चित रूप से अपेक्षित जानकारी 31.10.2023 तक अपलोड करना अनिवार्य है और यूजीसी के पत्र संख्या एफ.1-74/2016 (एआरसी) दिनांक अक्टूबर, 2023 (प्रतिलिपि संलग्न) के माध्यम से जारी निर्देशों के अनुसार यूजीसी पोर्टल- www.antiragging.in पर एंटी रैगिंग विनियमों का अपना अनुपालन प्रस्तुत करें। यदि जानकारी डीसीआई के ऑनलाइन पोर्टल पर 31.10.2023 तक अपलोड नहीं की जाती है, तो दोषयुक्त संस्थान/महाविद्यालय का नाम उक्त निगरानी समिति को उचित कार्रवाई के लिए भेजा जाएगा, जैसा भी उक्त निगरानी समिति द्वारा उचित और सही समझा जाए, उनके नाम डीसीआई की वेबसाइट पर भी अपलोड किए जाएंगे।

9. भारतीय दंत परिषद किसी भी प्रकार की रैगिंग के खिलाफ जीरो टॉलरेंस सुनिश्चित करती है।।

Sir/Madam,

I am directed to say that as per DCI Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, it is the responsibility of all the institution to ensure that no incident of ragging takes place in their dental institution and measures taken to curb it may be reviewed.

2. As per section 11.3 of the aforesaid regulations, the authorities/Management (Trust, Societies, etc.) of the institution, particularly the Head of the institution, shall be responsible to ensure that no incident of ragging takes place in the institution. In case any incident of ragging takes place, the Management/Head shall take prompt and appropriate action against the person(s) whose dereliction of duty lead to the incident. The authority designated to appoint the Head shall, in its turn, take prompt and appropriate action against the head.

3. All dental institutions should issue advertisements against ragging through signboards, pamphlets etc. before the commencement of academic year as well as during the midst of the session and also to issue booklets to all the students of your Institutions containing the details about what constitutes ragging,

punishable ingredients of ragging, punishments and penalty for ragging, names and mobile numbers of the members of the Anti Ragging Squad, Anti Ragging Committee (Anti Ragging Helpline), Wardens, Deputy Wardens of Men's and Women's hostel.

4. All dental Institutions shall designate any of their faculty member(s) as "Counsellor" for fresher and senior students to co-ordinate the batches of students (Counselees) regularly about day-to-day problems and also to sensitize their role in curbing the menace of ragging.

5. You are further requested to obtain and file an undertaking on Anti Ragging from all parents/guardians and students (1st year to final year) studying in BDS/MDS/PG Diploma/Para Dental Courses or any other course approved/recognized by DCI, online through www.antiragging.in

6. Besides above, it is also pertinent to mentioned here that, as per section 12.1 of subject regulations, each and every institution shall upload its reports on the online portal of DCI Module of Anti Ragging by 31st October of every year in respect of the previous academic session, indicating the requisite information against each column thereof, failing which the Dental Council of India, as per section 11.4 of Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, shall impose any one or any combination of the following penalties on it:-

11.4.1 To initiate the derecognition process against the institution under section 16A of the Dentists Act, 1948

11.4.2 To reduce the admission capacity of the institution to the extent to which the Council deem fit.

11.4.3 To stop further admission in the institution till further orders.

11.4.4 To stop renewal of permission in respect of UG/PG Dental Courses.

11.4.6 To post the information regarding penalties so imposed on the concerned institution on the website of DCI for information of all concerned.

7. In view of the above, I am directed to say that it is mandatory for all the institutions to upload the requisite information on the online portal of DCI Module of Anti Ragging as per request of the Monitoring Committee appointed by the Hon'ble Supreme Court of India and as per DCI Regulations on Curbing the Menace of Ragging in Dental Colleges, 2009, **for the academic session 2023-2024 latest by 31.10.2023, positively**, and submit your compliance of Anti Ragging Regulations on UGC portal- www.antiragging.in as per directions issued by UGC vide its letter No. F.1-74/2016(ARC) dated October, 2023 (copy enclosed). In case the information is not uploaded by 31.10.2023 on online portal of DCI, the name of defaulting institution will be forwarded to the said Monitoring Committee for such appropriate action as may be deemed fit and proper by the said Hon'ble Monitoring Committee, and their names will also be uploaded on DCI Website.

8. This may kindly be treated as 'Most Urgent'.

9. The Dental Council of India ensures Zero Tolerance against ragging of any sort.
