7. **The MDC shall defend, indemnify, and save harmless PWPL and its officers, directors, employees, agents, and representatives from and against any losses, damages, costs, attorneys' fees, penalties, fees, liabilities, or expenses associated with any claim of third party(ies)/its staff/its student(s) against PWPL connected with (i) death, or (ii) injury to persons or property, resulting from the acts or omissions of MDC or its staff/students.**
8. The MDC will be liable for any pilferage/loss of the PWPL due to negligence, omission or any other like act by their staff/student.
9. The MDC shall comply with all statutory requirements, rules, regulations issued/to be issued from time to time by the concerned authorities in relation to the SCOPE OF THE MOU. The MDC shall take necessary steps for safety of his staff/student while training at PWPL or in relation or connected with the said training.
10. If any dispute or difference arises between the parties in relation to or in connection with this agreement, they will undertake negotiations in good faith with a view to resolving the matter. If notwithstanding negotiations by and between the parties the dispute or difference of opinions is not resolved, either parties may refer the dispute, difference arising between the parties the breach thereof by arbitration as per the provisions of the Arbitration and Conciliation Act, 1996 in accordance with such Rules of Arbitration as may be agreed between both the parties. The award made by the sole arbitrator in pursuance thereof shall be binding on the parties. The place of arbitration shall be at Bhopal.
11. This MOU is not intended to, and does not create any right, benefit, or trust, responsibility, substantive or procedural, enforceable at law or equity, by either party, its officers, employees, or agents/students against the other party, its officers, employees, or agents/students.

13. MOU does not constitute and shall in no case be construed to create any relationship of agency, collaboration, association, joint venture, or partnership between PWPL and MDC or to impose any partnership/collaboration obligation of liability upon other party.
